### Information about privacy and Personal information processing

This website is operated by WEC Lines BV (hereinafter "WEC Lines"). WEC Lines is registered in the Netherlands at Albert Plesmanweg 59, 3088 GB, Rotterdam.

WEC Lines is committed to protecting your privacy. This Privacy Policy accounts for the Personal Information collected, processed, and used via <a href="https://weclines.com/">https://weclines.com/</a>.

By using this Website, you agree to the collection, use, and disclosure of your Personal Information in accordance with this Privacy Policy, where and as permitted by applicable law. If you do not consent to the collection, use and disclosure of your Personal Information as set forth in this Privacy Policy, please refrain from visiting this Website.

### What Personal information we collect

WEC Lines collects and processes certain Personal Information from you and your devices.

For the purposes of this Privacy Policy, "Personal Information" means information or data that identifies, relates to, describes, is reasonably capable of being associated with, or could be reasonably linked, directly or indirectly, with a particular naturally identified or identifiable person, consumer, device or in some circumstances household. It does not include de-identified, anonymized or aggregate information.

On our Website, the Personal Information collected will depend on which of our services you utilize. If you sign up to receive communications including news, updates and promotions from WEC Lines, we will ask for a first and last name, region, country, email address, telephone number(s) and language. We may then request your job title, position level, function, industry sector and trade information, but you have no obligation to provide us with these further details.

From time to time, we may also collect your Personal Information on landing pages for specific promotions or targeted events. In this case, we will request your first and last name, region, country, email address and telephone number.

Through our Website, you may conduct tracking, VSA, ISF and request shipping schedules, again, depending on your request, this may include Personal Information.

Should these functions not work, we make "user forms" available, (namely for tracking, searches on schedules, VSA, ISF, bookings, quotes, VGM and shipping instructions). In this instance, we will request your email address, first name, last name, telephone number, company name, country, and then depending on the form you fill in and the nature of your search, we may additionally request details on the shipper, consignee, notify parties, invoice company, responsible party, signature and forwarder which may contain Personal Information. When using these user forms, your IP address may be processed by us.

#### Cookies

Like many other websites, WEC Lines and its service providers use cookies to collect information about visitors' use of the Website. Our Website uses cookies to distinguish you from other users of our Website.

Cookies are small text files assigned to your browser to collect internet log on and visitor tracking information (including IP address, browsing history, and geolocation data, where and as allowed by applicable law).

The information is used to track visitor use of the Website to compile statistical reports on Website activity. This helps us to provide you with a positive experience when you browse our Website and also allows us to improve our Website. We also may use cookies to provide you with information on products or services that may be of interest to you, where and as allowed by law. You may delete cookie files from the device you use to access our Website at any time by clicking on the Privacy or History tab typically found on the Settings or Options menu in your internet browser. ### Information we collect from other sources

From time to time, we may obtain information about you from third-party sources and third-party data providers. We make best efforts to ensure such third parties are legally and contractually permitted to disclose such information to us. Examples of the information we receive from other sources include demographic information, device information, location, and online behavioural data (such as information about use of other websites, page view information, search results and links).

We use this information, alone or in combination with other information (including Personal Information) we collect, to enhance our ability to provide relevant marketing and content to you and to develop and provide you with more relevant updates, news, promotions, features and services. Third-party sources:

- Lead Forensics is a website visitor identification software. They collect, use, and protect visitor data. They focus on identifying businesses visiting websites based on IP addresses and publicly available information, rather than collecting personal data like names or email addresses. They do not collect sensitive personal data.

Those periods are also based on the requirements of applicable data protection laws, applicable legal and regulatory requirements and periods relating to the commencement of legal actions.

#### Disclosure of the Information

We may disclose your Personal Information to WEC Lines' agents worldwide or to third parties who act on our behalf, such as our Website analytics provider. This is done in order to process the Personal Information for the business purposes outlined above. Such third parties, or agents are contractually bound to comply with similar and equally stringent undertakings of privacy, security and confidentiality.

We may also disclose your Personal Information to a third party if necessary to fulfil a request you have made or transaction you have initiated, if we are required to do so because of an applicable law, court order or governmental regulation, or if such disclosure is otherwise necessary to support any criminal or legal investigation or proceeding.
