### 2. CONTAINER CLEANING

*All above costs include depot or terminal moves and lifts in/out for cleanings or repair station, unless otherwise stated.*

*Carrier owned equipment must be returned as prescribed to the assigned container depot. All equipment must be returned without lashing material, labels, or any debris inside the unit. Before the container is returned empty the unit must be cleaned and brushed from the inside. In case the unit is not returned back in sound condition, cleaning charges will be invoiced to the Merchant. WEC Lines reserves the right to apply additional charges in case of any pollution. Damage to container will be charged according to the interchange report or official repair estimate including additional moves on the depot or terminal.*

Additional costs that are incurred (such as demurrage and detention costs, storage costs, etc.) will be charged to the shipper as per "Local Charges" unless otherwise stated. The shipper has no right to claim any incurred costs caused by the delay in the schedule.*
